May 1, 2023 is the last day that you can mail your registration. Registrations mailed after May 1 (with the postmark date as proof) will not be accepted and will be mailed back to you.

This form must accompany your File Update form that's mailed to you in mid-February. If you have not received a File Update form by March 31, contact us at plr@canadacouncil.ca.

You must provide support material for all the titles you are registering. Please refer to step 2 in "How to register titles."

Your contribution must represent at least 10% of the audiobook and the number of contributors per audiobook (authors, translators, narrators) cannot exceed six.

How to register titles

2. For each audiobook title, provide support material that shows the credit for the author and the narrator, the ISBN, and the year of publication. This may consist of:
 - a photocopy of the audiobook box cover or bibliographic record, or
 - a screenshot of a Web page.
