Before you start

May 1, 2025 is the last day that you can mail your registration. Registrations mailed after May 1 (with the postmark date as proof) will not be accepted and will be mailed back to you.

Your 2025 results will be mailed to you in February 2026.

You must provide support material for all the titles you are registering. Please refer to steps 2 and 3 in "How to register titles."

To receive proof that your registration form was received by the PLR office, you can:

- send your form by registered mail, or
- include a self-addressed, stamped envelope with your form.

Your contribution must represent at least 10% of the book and the number of contributors per book cannot exceed six (this excludes the editors and translators, but includes photographers, illustrators and narrators).

You may register a maximum of 20 new titles per year. For complete eligibility criteria, consult the website.

How to register titles

- 1. Use the legend below to fill out your form.
- 2. For each print or e-book title, provide photocopies of the following pages:
- the title page (on which your name and the title of the book appear),
- the copyright page, and
- the table of contents, if there is one.

Note: Editors must indicate their written contribution (include the number of pages) on the photocopy of the table of contents.

- 3. For each audiobook title, provide support material that shows the credit for the author and the narrator, the ISBN, and the year of publication. This may consist of:
- a photocopy of the audiobook box cover or bibliographic record, or
- a screenshot of a Web page.
