### Eligibility:

Make sure that **you**, your **contributions**, and your **titles** are eligible by consulting the PLR Program's eligibility criteria on our website at [publiclendingright.ca/eligibility](http://publiclendingright.ca/eligibility) before you fill out this form.

### How to submit titles:

- 1. Enter relevant information on this form** (please consult the instructions on page 2).
- 2. Provide the required support materials:**
  - **For print and e-book titles:**
    - a photocopy of the **title page** (on which your name and the title of the book appear),
    - a photocopy of the **copyright page**, and
    - a photocopy of the **table of contents**, if available.
    - **Editors** must identify their written contribution (including the number of pages) on the photocopy of the table of contents.
  - **For audiobook titles:**
    - a photocopy of the **audiobook box cover or bibliographic record** (on which you are credited) and that shows the ISBN and year of publication.
